OUR DISTRICT

The Casa Grande Elementary School District comprises eight elementary schools, three middle schools, one C-STEM Academy (COIL), and one Early Childhood Learning Center (ECLC) serving about 6,500 students. With approximately 950 employees, the Casa Grande Elementary School District is presently the second-largest school district in Pinal County and is one of the largest employers in the county. The current annual operating budget is over \$70 million which is supported by a 10% budget increase approved by our community in 2023. Our boundaries encompass over 400 square miles and lie within the municipal boundaries of the cities of Casa Grande, Maricopa, and Eloy. Our District also lies within the growth boundaries of the City of Coolidge. Every day we strive to fulfill our district mission, "Success for Everyone, the Responsibility is Yours and Mine."

POLICIES & PROCEDURES

ANNUAL ACHIEVEMENT TESTING

The state of Arizona requires that student achievement tests be administered each year. The state tests are administered annually in Grades 3-8. Test results are provided to parents. State testing is one of the ways the Casa Grande Elementary School District measures student achievement. Other assessments are used throughout the year to monitor student progress and to make adjustments.

ATTENDANCE AND TARDINESS

Regular attendance will help a student enjoy school and reach his/her full potential. Absences and tardiness disrupt learning and cause a student to be less successful in school. Students should be in school each day unless they are ill.

Parents are responsible for notifying the school **in advance or at the time of any absence** from school. The parents also must provide at least one (1) telephone number, if available, so that the school can promptly notify them of any absence. This telephone number must be given at the time of enrollment of the student, and the school must be notified promptly of any changes in the telephone number.

BUS INFORMATION & RIDERSHIP IDs

Elementary students living more than one (1) mile from school are eligible for bus service. Students must follow all rules and regulations concerning bus transportation (found in the Bus Rider Pamphlet) in order to assure the safety of all children. Those students who do not follow the bus rules may lose the privilege of riding the school bus. If students are suspended from the bus, parents will be responsible for providing transportation to school.

Students must have written permission from parents and the principal to board or leave a bus that is not their designated bus or bus stop. Students must behave properly at bus-loading areas. Students who damage or deface school property, including buses, will be disciplined and will be required to pay for any necessary repairs.

Every student who has been approved for transportation within Casa Grande Elementary School District #4 will be issued a Student Identification (ID) Card at the beginning of each academic year or upon enrollment. Student Identification (ID) Cards will include the student's name, grade, student ID number, barcode and a recent photograph. KG Student Identification (ID) Cards will be colored coded Yellow for the ease of immediate identification for drivers. Grades 1st – 5th will be a consistent color district wide and will carry the district logo giving students ease of transferring from school to school without the requirements of obtaining a new Student Identification (ID) Card. Middle School Student Identification (ID) Cards will be universal and school specific.

All students are required to carry their Student Identification (ID) Card in order to ride the school bus or district van from school to designated stop. Student Identification (ID) Cards must be visibly displayed upon request by school staff, school bus or van drivers or authorized personnel. Students may download the “Here Comes the Bus” app and use their phones to scan onto the school bus or district van verses using their Student Identification (ID) Cards.

Students are responsible for the safekeeping of their Student Identification (ID) Cards. In the event of loss, theft, or damage of a Student Identification (ID) Card, students must report it immediately to the school administration. A replacement Student Identification (ID) Card may be issued to the student upon payment of a replacement fee of \$5, as determined by the school administration.

Failure to comply with this Student Identification (ID) Card usage procedures may result in disciplinary action, as outlined in the Casa Grande Elementary School District #4 Student Code of Conduct. Repeated violations may lead to progressive disciplinary measures, including but not limited to detention, loss of privileges, or suspension.

CAFETERIA

Breakfast and lunch costs are announced at the beginning of each school year. A child may charge a meal only in an emergency. Prompt payment for charged meals is expected.

Casa Grande Elementary Schools participate in a federally subsidized program that offers free and reduced-price meals to students who qualify, based on family income. Paper applications are available at your school’s front office, Nutrition Services office, and the district website. Visit us at www.cgesd.org or contact 520-876-3411. You are always welcome to join us for breakfast and lunch when you visit the school. Parents and school staff members have the option to purchase a meal at the adult meal price.

CELL PHONE & PERSONAL DEVICE PROCEDURES

Although school officials would prefer that cell phones and additional personal devices be left at home, we recognize the value that many families place on these devices for providing for the safety and well-being of their children.

If students bring cell phones to school, parents need to be aware of the following:

- Cell phones must be turned off during the school day, during passing periods between classes, or while riding a school bus. They should be stored so that they will not distract from learning, or lead to incidents of theft or damage, such as might occur on the playground, bus, etc.
- Cell phones that are in use during the school day or on school buses are subject to confiscation by the principal’s office. Students who have been guilty of misconduct with a cellular telephone may be required to check the telephone in and out of the office each day.
- Schools are not responsible for loss, damage, or theft of cell phones or other personal devices.
- While students are on campus, cell phones may be turned on outside of school hours only with the permission of the principal or his/her designee.

- Students in possession of cell phones with offensive or inappropriate photos or texts may be subject to disciplinary action and criminal charges, even if the photos or texts originated from an off-campus source.
- District Policy JIH provides that school officials have the right to search students' personal property, including cell phones, when there is reason to believe that the search will produce evidence of a violation of the law or school rules.
- Students who violate school rules concerning cell phones are subject to discipline including detention, suspension, and expulsion

Parents with questions about the use of cell phones and other personal devices should contact their child's teacher or the school principal.

CURRICULUM

CITIZENSHIP AND PERSONAL DEVELOPMENT

Instruction is designed to foster self-reliance, cooperation, responsible behavior, and goal-setting. Emphasis is also placed on leadership, respect for others and problem-solving.

FINE ARTS (K-5 uses Quaver; students access digital learning materials through Clever)

All students in Grades 1-5 have a regularly scheduled Fine Arts class to develop skills in music, performance arts, and/or Art. In addition, students in Grades 5-8 may participate in band.

GIFTED AND TALENTED DEVELOPMENT

Gifted and Talented services are provided to identified students based on need in grades K-8. We utilize the 95th or above percentile on state-approved tests or through the use of established multiple criteria measures for gifted identification. Within the Multi-Tiered Systems of Support Framework (MTSS), learning opportunities are modified based on student needs by classroom teachers with adjustments in abstraction, complexity, pace, and depth through a variety of materials and instructional practices. Opportunities exist for any child to be screened for gifted and talent development services. Students will continue to access foundational skills within the general education classrooms via differentiation strategies. A Gifted Plan (GP) will be developed for students identified as gifted to outline their present levels, specially designed instruction, and individual goals and objectives based on critical thinking skills, self-directed learning, positive self-concepts, positive interpersonal relationships, and creative thinking & expressions. All learning opportunities are geared towards the ongoing assessment of needs for additional specialized interventions and/or accommodations. Students will receive support and guidance to develop socially and emotionally as well as in their area of talent. Contact your school principal with questions regarding the gifted identification process or the provision of Gifted and Talented services.

MATHEMATICS (K-5 uses HMH Into Math; 6-8 uses Amplify DESMOS; students access digital learning materials through Clever)

Concept development, practical application computation, and problem-solving skills are emphasized at every grade level. Math instruction is developmentally based and designed to prepare our students to successfully apply math concepts and methods to solve the many daily problems they will encounter which require numerical reasoning.

MEDIA CENTER

Media centers not only include library books, but other exciting learning materials as well. These books and materials are for student and teacher checkout. The emphasis is on using the resources available for the development of research skills and for enrichment activities. Help your child learn to care for library books and return them on time so others may use them. Students are charged for books damaged or lost.

Library agreements are sent home each year for parents/guardians to give permission for their child to check out library books. Legal parents and guardians may request a list of books and materials borrowed at any time by contacting the school's Media Center Assistant or the District Librarian. PHYSICAL EDUCATION

Physical education is required for all students in Grades 1-5. Skills and motor activities appropriate to the age of the students are taught. For students in Grades 6-8, physical education is an available elective class for middle school students. Please see your school registrar for elective course listings.

READING/LANGUAGE ARTS (K-5 uses Amplify CKLA; 6-8 uses HMH Into Literature; students access digital learning materials through Clever)

The Casa Grande Elementary School District offers a Language Arts Program that emphasizes the integration of Reading, Writing, Listening, Speaking, and Language Concepts. The development of students' phonemic awareness, phonics, vocabulary acquisition, reading comprehension, and appreciation of literature is emphasized in each reading lesson.

Daily experiences in reading are extremely important to becoming a good reader. Teachers in the Casa Grande Elementary School District provide students with experiences that will improve their fluency in phonics and word recognition, as a means of enabling them to make meaning from what they read. Throughout the Language Arts Program, students are required to complete products or outcomes to demonstrate their understanding of written and spoken language. Such products or outcomes may include written expression, remarks during a discussion, or an oral, dramatic, artistic, or graphic presentation.

The Language Arts Program consists of basal texts, core literature, phonics, language experiences, and reading instruction in all content areas. The District's goal is to equip each student to skillfully use written and spoken language as a means to fully profit from participation in the educational system and to become informed, thinking citizens.

SAFETY, HEALTH, AND NUTRITION

Students learn about basic anatomy, wise food choices, and proper exercise. Also included are such things as avoiding accidents at home and school, traffic safety, dealing with emergencies, chemical abuse prevention, and personal safety. A summary of the Governing Board's policies relating to substance abuse prevention is included in this handbook.

SCIENCE (K-5 uses Discovery Science; 6-8 uses Amplify Science; students access digital learning materials through Clever)

The Casa Grande Elementary science program is designed to teach science concepts and is used with a variety of demonstrations, experiments, and projects.

SOCIAL STUDIES (6-8 use Pearson myWorld Interactive; students access digital learning materials through Clever)

Lessons cover social, economic, historical, political, and geographical relationships affecting the family, community, state, nation, and world.

CUSTODY – PARENT VISITATION RIGHTS

In most cases, when parents are divorced, both mother and father continue to have equal rights to their children. However, if you have legal papers that limit the rights of one parent in matters such as custody or visitation, please provide a copy to the school. Unless this information is on file in the school office, equal rights must be provided to both parents.

DIGITAL LITERACY

The Governing Board of the Casa Grande Elementary Schools believes it is important for students to be introduced to the computer as a basic tool in education. The goal of computer education will be to teach students digital literacy, digital citizenship, and critical thinking. CGESD uses the Arizona Computer Science Standards and the Arizona Educational Technology Standards in its Digital Literacy and Computer Science instruction.

HEALTH TECHNICIAN/SCHOOL NURSE

Registered nurses and health technicians provide important vision and hearing screenings for students throughout the school year. These health screenings help identify potential issues impacting a child's learning abilities. If you do not wish for your child to participate, please contact the school health office.

EMERGENCY CARDS

We require all parents to complete an emergency medical referral card for each of their children every year. This card tells us how to contact you or another responsible adult if your child becomes ill or is injured at school. Please let us know if your address, home phone, business phone, or emergency phone number changes. It is of vital importance to keep each student's emergency card up-to-date. Ailments such as diabetes, epilepsy, cardiac disease, asthma, and allergies are some of the diseases that should be noted on health records and discussed with the school nurse.

HEALTH HABITS

The following are important health habits:

- Get plenty of sleep.
- Eat a balanced diet.
- Wear comfortable clothing and sturdy shoes.
- Bathe regularly.
- Brush your teeth after eating and before going to bed.
- Wash hair regularly. Head lice can be a problem affecting many children because it is a very contagious condition. Children should not share combs and brushes with classmates.
- Wash hands before and after meals and after using the bathroom. This is the single most important factor in the control of hepatitis and a host of other contagious diseases.

If you have questions about good health habits, contact your family doctor, clinic, or your school nurse.

IMMUNIZATIONS

Many advancements have been made in medicine to help prevent childhood diseases. To help protect your child, Arizona law requires immunization against Rubella (measles), Rubella (German measles), Poliomyelitis, Diphtheria, Tetanus, Pertussis, Hepatitis B, and Mumps. As with most rules, there are exceptions. Children can be exempted if a physician certifies that one or more of the immunizations would endanger the child's life, or if parents submit a signed statement that immunizations are contrary to their religious or personal beliefs.

Although the law allows exemptions, the Pinal County Health Department may tell us to exclude your child from school if there is an outbreak of any of these diseases.

**ALL CHILDREN MUST HAVE VERIFIABLE RECORDS OF

MEDICATION

If your child needs to take medication at school, bring it to the nurse's office and complete a **Consent for Medication** form. Information on the form includes the child's name, dosage, time of day to be taken, and expected duration of treatment. By law, we cannot dispense medication unless it is in the original, labeled container. Over-the-counter drugs, such as aspirin and cough syrup, are dispensed under the same guidelines because seemingly harmless drugs can be misused and cause severe reactions.

WHEN TO STAY HOME

We think good attendance is vital, but not when it may jeopardize the health of others. If your child becomes ill at school, we will notify you as soon as possible. The best place for a sick child is at home, in the care of mom or dad. If you think your child may be ill, check with your doctor before sending him/her to school.

Some signs of illness are:

- Restlessness at night
- Nausea or vomiting
- Fever
- Red, watery eyes
- Runny nose
- Flushed face
- Sneezing and coughing
- Headache
- Sore throat
- Facial Swelling
- Rash

Children with these symptoms do not belong in school. For their own well-being and for the safety of others, children should wait until they are completely well before returning to school.

INSURANCE

Accident insurance for students is available from a private insurance agency. This insurance is a limited accident policy and is available at any time during the school year in the school office.

LEAVING SCHOOL EARLY

There are occasions when parents wish to check students out of school before the end of the school day. Parents must report to the school office to sign children out of school. A note should be sent to the child's teacher in the morning if parents would like to have their child dismissed early on any given day. If students return to school before the end of the school day, they must check back in with the office before reporting to their classrooms.

LOST AND FOUND

Please check with the school office for any items lost at school. Items can be more easily returned to the rightful owner if the child's name appears on the lost article.

MAKE-UP WORK

It is very important for students to make up for missed work when absent from school. **It is the student's responsibility to ask the teacher for make-up work.**

Parents may call the school to request make-up work for students who may be absent for several days. Please give the teachers and office 24 hours to collect homework assignments. If you have a question regarding your student's assignments or grades, please contact your student's teacher.

PARENT'S RIGHT TO KNOW

As a parent of a student in the Casa Grande Elementary School District, you have the right to know the professional qualifications of the teachers who instruct your child. Please speak with the school principal to obtain more information.

PREVENTION OF STUDENT CHEMICAL USE AND ABUSE

The purpose of this policy is to educate and protect the students and staff of the school concerning the non-medical use of chemicals. Alcohol, narcotic drugs, marijuana, and other dangerous drugs shall be considered chemicals when interpreting this policy. This policy includes the possession or use of chemicals on school property as well as during school activities off school property. It is the responsibility of the school district to teach health education, aid in personal development, attitudes, and maintain proper discipline.

This policy specifically forbids any pupil or other person to be under the influence of, to use, to have in his/her possession, or to distribute in any way, drugs and alcohol on school property or at school-sponsored activities off school property. All school district employees shall be responsible for alerting designated personnel as to possible chemical use or abuse by students.

Law enforcement agencies, proper medical personnel, and parents shall be notified when a violation of this policy may occur. Searches of lockers, outer clothing, desks, purses, and backpacks or similar items within the school or at school-sponsored activities may be conducted. When it has been determined that a student is involved in the distribution, possession, or use of chemicals, he/she may be suspended for up to ten school days and referred to the Superintendent for further action. A hearing may then be held at which time the District may return the student to school, extend the suspension, expel the student, or follow alternative procedures.

All medication must be kept in the nurse's office. Students who need to have access to medical drugs shall have a signed note from their parents with written directions about how to use the drug as provided by the physician. Students who are in the possession of medically approved drugs, but have not followed the directions described above, shall be warned for the first offense. For subsequent offenses, he/she will be disciplined according to normal school disciplinary policies. Students who distribute such drugs to others will be considered, under the procedure, as distributing chemicals for non-medical purposes.

Student counseling on chemical use and abuse should be conducted by qualified counselors. This counseling should be available to students who desire this service. Trust between the student and staff will be maintained as much as possible. Student needs and the health and safety of the student and others will be addressed by all staff.

REGISTRATION

A child must be five (5) years old prior to September 1 of that school year to enroll in kindergarten. A child must be six (6) years old prior to September 1 of that school year to enroll in first grade.

A birth certificate or other acceptable proof of age of your child, a record of immunizations, and proof of residence are required if you are enrolling for the first time in our schools.

REPORT CARDS AND PARENT-TEACHER CONFERENCES

Students are issued report cards four (4) times during the school year at nine (9) week intervals. Parent-teacher conferences are scheduled twice during the school year, during the first and third grading periods. However, parents are encouraged to contact teachers on a regular basis in order to monitor their child's progress.

RESPECT FOR SCHOOL PROPERTY

The school buildings and equipment are furnished by the citizens of the community through tax dollars. This investment must be protected. Students who damage any school property will be held responsible for payment of repairs. In the case of minor children, parents will be held liable for damages. We ask parents to help us protect this community investment by teaching children respect for public property.

RETENTION or ACCELERATION

The purpose of acceleration or retention is to place students in the school program where the child's educational needs will be most appropriately served. Parents will be contacted at the end of the first grading period if there are indicators that their child is not meeting the standards for promotion. A parent conference will be requested at the end of the second grading period if the student continues to achieve below expected levels. Each child will be given individual consideration and decisions will be made only after careful study of the complete body of evidence.

SCHOOL COUNSELING

The CGESD comprehensive school counseling program is integral to the educational program. School counselors work closely with administration and instructional staff to support students and help students develop academic, social, emotional, and career skills that enable them to become productive citizens.

School counselors teach classroom lessons, meet with students individually and in groups, support families, and help with referrals to outside agencies when needed. If you DO NOT want your student to see a school counselor individually or in a group; please contact your student's school principal with your request.

SCHOOL DRESS CODE

Students should dress in a manner that, in addition to the following guidelines, takes into consideration the educational environment, safety, health, and welfare of self and others. Students must wear a shirt with pants or skirt or the equivalent (dress, leggings, or shorts).

- A. Clothing must not be see-through and must cover a student's undergarments, chest and torso, when standing or sitting. Bare midriffs, halter tops, and spaghetti straps are not acceptable. A bare midriff will be defined as any exposed skin between the bottom of one's shirt and top of one's pants.
- B. Shoes must be worn at all times. Closed shoes are to be worn for any type of physical activity, such as physical education, et cetera. Slippers and any footwear judged as unsafe may not be worn on campus.
- C. Jewelry shall not be worn if it presents a safety hazard.
- D. Clothing, accessories and/or jewelry may not state, imply, or depict hate speech/imagery targeting groups based on race, ethnicity, gender, sexual orientation, gender identity, religious affiliation, or any other protected classification.
- E. Students may wear clothing, accessories and jewelry that display religious messages or religious symbols in the same manner and to the same extent that other types of clothing, accessories and jewelry that display messages or symbols are permitted.
- F. Subject to the above, no hats, bandanas, other head coverings, or sunglasses may be worn in a classroom or school building, except for properly approved occupational safety headgear required for special classes or if authorized by a school administrator or authorized/prescribed by a medical Professional.
- G. Obscene language or symbols, or symbols of drugs, sex, alcohol, or weapons on clothing are prohibited.
- H. Students may not wear clothing, accessories and/or jewelry with images, symbols, slogans, words or phrases that are profane, discriminatory or defamatory or that is worn with the intent to convey affiliation with a criminal street gang as defined in A.R.S. 13-105.
- I. Hats and sunglasses may be worn outside.

Exceptions for special activities or health considerations may be pre approved by the administrator.

Students who volunteer for extracurricular activities, such as athletics, band, chorus, et cetera, are subject to the standards of dress as defined by the sponsors of such activities.

SCHOOL SUPPLIES

The school district provides textbooks, paper, pencils, library books, and other school supplies free to all students. However, it is the student's responsibility to care for these materials. Parents may be requested to pay for any school supplies that are lost or not properly cared for by the student.

SCHOOL VOLUNTEERS

Adult volunteers often work at each school in various capacities during the school year. Parents, senior citizens, education majors in college, and retired teachers enjoy volunteering time to help students. If you are interested in volunteering, contact the school principal.

STUDENT CONCERNS, COMPLAINTS, AND GRIEVANCES

In accordance with Governing Board Policy JII, the Casa Grande Elementary School District has established procedures for addressing occurrences of bullying, harassment, and intimidation. Students, who feel they are the victim of harassment, bullying, or intimidation, have the right to anonymously provide a report to school officials. Within 30 calendar days of a complaint, a report must be made to a school administrator or professional staff member. All reports of allegations will be documented and investigated by the school administration

DISCIPLINARY ACTION

Casa Grande Elementary Schools have established the following guidelines to ensure consistency in discipline at all schools. We want parents to know that school rules are designed to protect all children and that students who break the rules will be treated firmly but kindly and appropriately.

All regulations governing the conduct of students apply while in school, traveling to and from school, and at school functions.

Most boys and girls will never have serious discipline problems, but to protect the rights of all our children, it is important that parents and students understand the consequences of misbehavior.

- **INFORMAL TALK:** A teacher or administrator will talk with the student to discuss the student's behavior. The parent may be contacted if necessary.
- **CONFERENCE:** A conference will be held with the student, the teacher, and the administrator to develop a plan for changing the behavior. The parents may be contacted if necessary.
- **PARENT INVOLVEMENT:** The parents may be contacted to schedule a conference with the student, administrator, and other school personnel to develop a plan for changing their child's behavior.
- **SUSPENSION OF PRIVILEGES:** The school administrator or teacher may notify the parent of privilege suspension. These privileges include bus, playground, cafeteria, media center, or classroom participation.
- **DETENTION:** Students who cannot follow school rules may be assigned detention. This takes place either before school, at lunchtime, at recess, or after school. If the detention takes place before or after school, parents will be notified prior to the detention. It is the parents' responsibility to provide transportation for before-school or after-school detention.
- **CONFINEMENT:** Confinement is permissible only with written parental consent, except in instances in which a student poses imminent physical harm to oneself or to others. Should confinement be used, then the principal or teacher is required to make reasonable attempts to notify the pupil's parent or guardian in writing by the end of the same day that confinement was used.

OFFENSES LEADING TO EXCLUSION FROM SCHOOL

The Governing Board of the Casa Grande Elementary School District defines the following types of offenses which may lead to short-term suspension, long-term suspension or expulsion from the District's schools. The type of exclusion from District schools will necessarily be dependent upon the facts of each particular offense, as disclosed.

Offenses of Possession, Use, Distribution or Sale

1. Possession of any dangerous weapon.
2. Possession of, or use of, alcoholic beverages on school property or during participation in any school-related activity.
3. Possession of, distribution or sale of, or use of any illegal drugs, drug paraphernalia or chemical substances on school property or during participation in any school-related activity.
4. Possession of, distribution or sale of, or smoking of any cigarettes, cigars, pipe or other tobacco products.
5. Possession of, distribution or sale of, any illegal or prohibited material.
6. Possession of, distribution or sale of, any explosive material or any material likely to cause harm or injury to others.
7. Possession, on the student's person, under a student's control or in the student's backpack or desk, of any item or substance the possession of which is a crime in Arizona.

Offenses Relating to Attendance and General Conduct

1. Unexcused absences from class.
2. Truancy.
3. Repeated violation of attendance laws.
4. Leaving school grounds without permission.
5. Being habitually late for school or class.
6. Misconduct on a school bus.
7. Refusal to serve detention when assigned to the detention hall.
8. Insubordination.
9. Use of obscenities.
10. Incurability - failure to abide by specific school rules in spite of previous disciplinary or rehabilitative efforts.
11. Attending school or school-related activity while under the influence of alcohol.
12. Attending school or a school-related activity while under the influence of illegal drugs or illegal chemical substances.
13. Sexual harassment.
14. Sexual misconduct.

Offenses Affecting Property of Others

1. Opening or entering, or attempting to open or enter, another student's locker[WU29] or desk without the student's permission.
2. Willfully damaging, or attempting to damage, walls, furniture, equipment, textbooks or any other real or personal property.
3. Stealing, or attempting to steal, any personal property.
4. Setting a fire or attempting to set a fire, in or around school buildings or on school buses.
5. Tampering and/or unauthorized use of security systems, or fire alarm or safety systems.

Offenses Involving Danger to Other Persons

1. Assaulting any other person.
2. Intimidation of others.
3. Performing any actions which constitute a hazard to oneself or to others.
4. Reporting by telephone, in writing, or in person, a threat known to be false.
5. Disrupting the school program, especially where such disruption interferes with the educational program of other students.
6. Actions constituting a danger to the welfare of others or to oneself.
7. Actions which corrupt, or tend to corrupt, the morals of minors.

Miscellaneous Offenses

1. Forging a signature on any school-related document, or presenting any school-related document with a signature known to have been forged.
2. Any conduct which disrupts classwork or involves substantial disorder or invasion of rights of others.
3. Any conduct related to gang activities.
4. Any action constituting a violation of the Arizona Criminal Code

SEVERE DISCIPLINARY ACTION

- A. **Parent custody** – students are released to the custody of the parent for the duration of the school day.
- B. **Summary suspension** – when the student's behavior causes a clear and present danger to self or to others, a suspension may be immediate.
- C. **Short suspension** – the school principal may suspend a student for up to nine (9) days. The parent and the student will be informed as to the District's due process procedures.
- D. **Long-term suspension** – a hearing officer may suspend a student for a maximum of one (1) calendar year. Formal notification will include instructions regarding the District's due process procedures.

STUDENT RECORDS

The Governing Board has established policies for the collection and release of student records. Parents may review their child's records and school employees will assist in interpreting these records. Parents are required to sign for the review or release of school records.

SPECIAL PROGRAMS

CHRONIC ILLNESS - [Homebound & Chronic Health Form](#)

The Casa Grande Elementary School District is committed to providing an appropriate education to all students including those with chronic health conditions resulting from illness, disease, or accident. Instructional provisions will be determined on an individual basis to ensure continuous learning that is integrated with the regular education program as much as possible. No student certified as having chronic health conditions will be penalized for absences as long as absences are due solely to illness, disease, or accident.

ENGLISH LANGUAGE LEARNERS' PROGRAM

The primary goal of our English language program is to develop proficiency in the English language, including listening, speaking, reading, and writing skills, to ensure students can comprehend academic content and effectively communicate with teachers and peers. The EL program aims to support English language learners in mastering grade-level academic content across various subjects, enabling them to meet the same academic standards as their English-proficient peers.

To become eligible for our program, parents must fill out a Home Language Survey (HLS) at the time of registration. If parents answer any question other than English or American Sign Language, they are then given the AZELLA (Arizona's English Language Assessment). If they are not proficient, parents are notified their students are eligible to receive EL services.

Students take the AZELLA Reassessment each spring to test for English proficiency.

HOMELESS EDUCATION ASSISTANCE

If your family is experiencing transitional housing, your child has certain rights including continuing their education in their home school, free transportation from transitional housing locations, and participation in the meal program. PBIS

All schools within CGESD implement Positive Behavioral Interventions and Supports (PBIS), a multi-tiered framework designed to meet the diverse needs of students. PBIS focuses on promoting positive behavior, preventing disciplinary issues, and fostering a safe and inclusive learning environment for every student. In addition, our schools are currently being trained in Restorative Practices, which aim to build community and resolve conflicts through inclusive dialogue and mutual understanding. We are also learning about the Neurosequential Model, which helps address the needs of students with emotional challenges by considering the developmental impact of trauma and supporting their unique emotional and behavioral needs. Through these comprehensive approaches, we strive to enhance academic and social outcomes for all students.

POLICE AND FIRE DEPARTMENTS

In cooperation with the Casa Grande Police and Fire Departments, officers may visit all schools instructing the students in bicycle/tricycle safety, fire safety, personal safety, drug/alcohol abuse prevention, and responsible citizenship.

HINTS FOR SAFETY- Please go over the following with your child:

1. Walking to and from school:
 - a. Start early enough so you arrive five (5) to ten (10) minutes before the bell rings, without rushing.
 - b. Walk on the sidewalk. If there is no sidewalk, walk to the left of the road, facing oncoming traffic.
 - c. Never run between parked cars.
 - d. Look in all directions before crossing the street. Use marked crosswalks.
 - e. Never accept a ride or a gift from a stranger.
 - f. Obey the crossing guard when present.
2. Riding your bike:
 - a. Cross only at marked crosswalks by walking the bike across the street.
 - b. Ride single, never double. Observe all traffic rules.
 - c. Use a chain and padlock on your bike. We suggest you register your bike with the Casa Grande Police Department. The school is not responsible for your bike or other personal property brought to school.
3. During the school day:
 - a. Play safely. Do not throw sand, rocks, or anything else that can hurt people.
 - b. Do not “roughhouse” or “play fight.”
 - c. Leave knives and other unsafe objects at home.
4. While at school or home:
 - a. Say “no” to drugs.
 - b. Only use medication following your parents’ directions and according to your physician’s prescription.
 - c. Report anyone who offers you drugs to your parents, police, teachers, or principal.
 - d. Ask for help if you have a problem with drugs. Talk to your parents, teacher, school nurse, principal, or school psychologist.

SPECIAL EDUCATION

The Casa Grande Elementary School District provides an array of special services to students identified as disabled under the Individuals with Disabilities Education Act (IDEA) from preschool (age 3) through the eighth grade. The special services selected for a student will be designed to support participation in the Arizona Academic Standards at a level appropriate to the child. Special education services may include children enrolled in private and home schools within the Casa Grande Elementary boundaries of jurisdiction. Appropriate referrals will be given to students 0-3 years of age.

The established policies and procedures and/or parent rights for special education services in the areas of Child Find, Evaluation, Free Appropriate Public Education, Discipline, and ESY may be obtained or viewed by contacting the Office of Learning Support at 876-3244.

TITLE 1 PROGRAM

Title I services are educational programs designed to provide additional support and resources to students who may need extra help to succeed in school. They offer personalized assistance in areas like reading, math, and language skills to ensure that every student has the opportunity to excel academically. These services aim to level the playing field and help all children reach their full potential, regardless of their background or circumstances.

TECHNOLOGY

CGESD provides 1:1 Technology for our Middle School and CGESD Online Learning Academy students. At our elementary schools, classroom devices are provided in a cart for student use. Devices are checked out to students at the middle schools and the CGESD Online Learning Academy. They may also be checked out to individual students at the elementary schools and COIL based on program needs. Kindergarten and 1st-grade students use iPads. 2nd through 8th-grade students use Chromebooks. Depending on individual student needs, a different device may be used by students other than those listed here. These devices are school property and should be treated with respect, as stated in the previous section "Respect for School Property."

DEVICE PROTECTION PLAN (DPP)

A Device Protection Plan is offered by CGESD for devices checked out to students at the middle schools and the CGESD Online Learning Academy. The Device Protection Plan is \$25 per device. Parents/Guardians need to opt in by completing the Device Protection Plan Agreement form and submit payment by the 8th day of school (or the 8th day of enrollment if after the start of the school year). The Device Protection Plan is not in effect until both the agreement and payment have been received by the school site. Intentional damage is not covered by DPP- the full fine amount is charged if the damage is found to be intentional.

The fines to be charged for device replacement and repairs are listed below:

Fines will be assessed based on an assessment of damage by a CGESD IT Technician and reported to the school site. The school site will inform parents/guardians of any fines incurred by their child as soon as it is determined. Invoices will be provided by the school site to the parent/guardian.

STUDENT ACCOUNTS

All students are provided a Google Workspace for Education account that includes email. A “walled garden” is set up so that students can only share files and communicate with students and staff within Casa Grande Elementary School District. Accounts for students are also set up for additional educational programs. A list of all approved digital programs can be found at <https://cgesd.app.learnplatform.com/new/public>

DIGITAL SAFETY

Filtered internet access is made available to all students. WiFi is available at all school sites. District devices are configured to automatically connect to this network. In addition, all student accounts are monitored for appropriate use using the Bark for Schools program. Bark for Schools notifies school administrators of concerning online behaviors including, but not limited to, cyberbullying, profanity, violence, hate speech, sexual content, depression, and suicide/self-harm. Legal guardians will receive a notification to set up an account within the Bark for Schools Parent Portal in order to receive alerts for after-school hours and during breaks. In middle school classrooms, Lightspeed Classroom is used by teachers to monitor students’ use of devices. Appropriate use expectations are outlined in the CGESD Acceptable Use Agreements.

VISITORS ON CAMPUS

Visitors are always welcome, and we encourage parents to visit our schools. However, for the safety of the students, all parents and other visitors must report to the front office for a visitor's pass. We currently use the Raptor Visitor Management system and ask all visitors 18 and older to present a government-issued ID.

If the purpose of the visit is a student or classroom observation, this must be planned in advance with the site administrator.
