- 8.01 Mrs. Draper presented on A-F Accountability and school letter grades. She shared the timeline the State Board lines out for the preparation of letter grades. The district has no schools in appeal this year. The district has one A school, three B schools, seven C schools and one D school.
 - Mr. Cruz asked about the opportunity for an A+ application for the schools who might qualify through AEF. The Board will be updated.
- 8.02 Mr. Raymond presented the COIL proposal for growth and expansion. Community interest and school/programming needs have justified a consideration to accelerate the growth at COIL. It is proposed that grades K, 1, 2, 3 and 7 are added for the 24/25 school year. By offering grades K-7 at COIL next year, it will give the ability to serve more sibling groups, begin the foundational CSTEM-focused education model in the early grades, and increase learner-driven opportunities for all. Discussion included: how the program will look for younger students, doing the expansion right including the team and classroom needs, and opportunities for community members to come in with projects.
- 8.03 School Safety Update This item will be postponed to January, as the presenter was unable to attend this meeting.
- 8.04 Information pertaining to the revision of the 2023-2024 budget had been included in the Board's information. The public hearing provides the general public an opportunity to provide input with regard to the proposed revisions.
 - Ms. Wheatcroft presented the proposed revision of the 2023-2024 Budget. The district was not required to revise the budget, but due to some minor changes, it was practical

to do so. ESSER moves were discussed as this is a common thread in Arizona schools, but CGESD is in a strong financial position to face the loss of these funds.

Mr. Stabley declared that the public hearing for the proposed revision of the 2023-2024 budget hearing be opened at 7:51 p.m. There were no questions or concerns from the public. Mr. Stabley closed the public hearing at 7:51 p.m.
