3.01 Dr. Leckie recognized Making Your Mark! recipients Guillermina Lorona, Brett Wetteland, Natasha Ibarra, Aurora Tanaka, and Lorie Hill.

4.01 Call to the Public

There were no requests to speak.

5.01 Mr. Vispi Karanjia and Mr. Saravanan Bala with Orcutt/Winslow presented a general overview of the Capital Master Plan work and the anticipated outcomes. Mr. Karanjia introduced the company with a short bio and images of some of the work they have done with other districts. He stated that the process is three-fold with strategic planning, bond strategy and innovative renovations.

Mr. Bala then went into the process in further detail. As the process of engaging the community begins, what should drive the conversation, what are we trying to achieve as a district. Strategic education plan must drive the conversation. How do the spaces have to align? The ultimate goal of educating students is to educate them to be successful members of society. The foundation is having community support. Who is involved: stakeholder groups, parents, teachers, students, staff, and businesses.

Have the community prioritize needs. Holding school engagements, polling, etc. will allow the community to give ideas of what capital needs they feel exist.

Dr. Leckie stated the process will allow the district to recreate learning spaces to prepare our students for the next generation workforce.

Mr. Stabley commented on concerns about the growth that will be happening in the northwest corner of the district and how the district will plan for new facilities. Mr. Karanjia replied that the process creates alignment and gives a roadmap about future growth and how the district will bring on new facilities.

8.02 The Governing Board met in Executive Session to discuss the Superintendent’s Performance-Based Pay for FY 22-23.

As approved by the Board in September, there were four goals established for the Superintendent’s Performance Goals for 2022-2023: Early Literacy Proficiency, 8th Grade Math Proficiency, School Climate and Attendance. Dr. Leckie reported to the Board the progress achieved, the strategies the district currently has in place, and improvement strategies.

Mr. Stabley commented that this first year has been a year of growth and change and

he is personally happy with the direction the district is going and that next year will be even better.

Mr. Cruz commented that he was not here for the initial evaluation, however, since his appointment he has been able to observe the work Dr. Leckie has done and feels he can make an informed decision based upon his goal set. Coming into this Dr. Leckie had his hands full coming into a district that was finishing the COVID situation which impacted learning, households and families in the community. Dr. Leckie has been very involved in the community, attending different events, listening to parents, students and staff. Dr. Leckie has found new pathways to move the district forward. One of our core values is excellence and we want to ensure excellence is met and when it is not met, we have to think about opportunities to improve it. Mr. Cruz feels it's important we recognize Dr. Leckie's work, but also recognize that goals were not achieved.
