Mrs. Lisa Bradshaw presented information regarding the Data Warehouse and Dashboard Platform. Currently district data lies in several different places. A data dashboard can pull information in and pull it quickly, and incorporate information from other data. The district knew there was a need and wanted a product that would grow with the district. The top three proposals from vendor responses provided demonstrations of examples. The platform being recommended, is Decision Ed. Decision Ed is currently being used by a significant number of partner districts, so they know Arizona districts. Their business is designing dashboards for schools.

The total cost over 4 years is \$427,520.91. That cost includes annual licensing, deployment and integration services, training and professional development, and support and maintenance. If the district decides the dashboard needs a redesign, Decision Ed will redesign at no additional cost. All three referencing districts stated their customer service is top notch.

The dashboard will be designed keeping the audience in mind, including teachers and school site staff input in the design. Benefits of the dashboard include the ability to act on data quickly, customer service, and ease of use.

Mr. Stabley asked who will enter data into the system. Mrs. Bradshaw responded that the dashboard will pull data from different programs by creating connections that will pull data nightly. Decision Ed will help design connections that can also import spreadsheets.

Mrs. Varela asked who will be trained. There will be a cohort of train the trainers and they will then train teachers.

Mrs. Sisson moved to authorize the award of RFP #192-1524 for a data warehouse and dashboard platform to Decision Ed Group, Inc. as recommended.
