

## **Device Protection Plan**

This agreement is specific to the individual student named and their respective parents with the Casa Grande Elementary School District. Unless otherwise indicated, this agreement is valid until the end of the current school year.

Enrollment in the plan will minimize the potential repair and/or replacement costs associated with the device. By selecting this plan, you agree to pay an annual fee to be enrolled in the Device Protection Plan (DPP). Annual fees and charges for repairs/lost/stolen devices are set annually by the Casa Grande Elementary School District #4 Governing Board.

By signing this agreement, both the student and parent acknowledge that

- The Device Protection Plan is optional.
- Parents and students who choose not to purchase the Device Protection Plan are responsible for 100 percent of all repair and replacement costs for the device.
- Enrollment in the DPP does not begin until the full payment is received and must be completed no later than the 8th day of school (or enrollment).
- The device protection plan is transferable to any other school in the district within the school year. There will be no refunds given on the original DPP purchase if a student leaves CGESD.
- If the device is stolen while at school, the incident must be reported by the student to their teacher or front office within 24 hours.
- If the device is stolen outside of school, a parent/guardian must file a police report within 48 hours. A copy of the report must be turned in to the school principal.
- Intentional damage to the device is not covered under the plan.

Fines will be assessed based on an assessment of damage by a CGESD IT Technician and reported to the school site.

The school site will inform parents/guardians of any fines incurred by their child as soon as it is determined.
