## Meeting Summary February 25, 2020

Ed Sloat reviewed the meeting agenda and goals.

Ed reviewed a draft of core planning (guiding) principles based on task force member input from the activity at the February 4 meeting.

- [Safety]: Safety: Walking Students Crossing Major Roads, Traffic (congestion)
- [Diversity]: Diversity, Inclusive, Impact on Title 1 programming, FRPL, CEP, Distribution of Wealth
- [Stability]: Stable, Only Move students if you have to
- [Facility Equity/Efficiency]: Equitable, Resource use efficiency, Message to Taxpayers
- [Community]: Sense of Community, Neighborhood/Community School, [community] Accessible School Grounds/facilities, Group Culture, Engaging, Inviting
- [Space Utilization]: Class Size (Manageable), Room for Growth, Considerations for Learning Space, Open Space Allocation, Flexibility of Programming,
- [Education Pathways]: Alignment Pathways (ES -> MS -> HS)
- [Geographic Consistency]: User Friendly Map
- [Relationships]: Relationships (Teachers over years); student/staff well-being
- [Transportation]

Task force members provided feedback regarding each of the draft core planning principles. The consensus of the group was to remove "Relationships" as an individual guiding principle as it is implied in several of the other core planning principles. Ed Sloat will update the guiding principles based on the feedback from the group and present them for approval at the next meeting.

Ed reviewed a sample of a checklist to evaluate attendance boundary scenarios for alignment to the guiding principles. The consensus of the group was to utilize a 1 to 5 rating scale for each guiding principle.

Tom Wohlleber reviewed the methodology utilized to calculate the program/functional capacity for each school.
